Frequently Asked Questions

What is the duration of my enrollment?

You will have five years to complete your qualification. The five-year period starts from the date you passed your first successful unit (we call this the 'declaration date'). Any unit that is five or more years old will not count towards the qualification and you will need to retake this/these unit(s) if you still want to complete the qualification.

When do I receive my results?

Complete a Virtual Closing Interview for assessment results release. English assessment results, including practical applications, arrive within 40 working days from the exam or assignment submission, specified on your confirmation. Qualification grade depends on Unit IG1 result; Distinction (75+), Credit (65-74), Pass (45-64). Both units (IG1 and IG2) must pass for parchment issuance. Upon completing both units, expect a qualification parchment in 40 working days. Individual Unit certificates available on request to Nebosh at an extra cost. Results declared within 50 working days, certificates issued in 40 working days from the result declaration.

What is the process for the IG2 Practical Examination?

IG2 is a practical risk assessment that assesses what you can do. It is marked by external examiners appointed by NEBOSH. These examiners are chosen for their experience and expertise to ensure that learners are assessed by the best from our industry. It is held on a date set by Safeguard and must be taken within 7 days of a written examination. Unit IG2 is 'Pass' or 'Refer' and does not count towards the qualification grade but must be passed in order achieve the qualification.

What are Re-Sit Exams

You may re-sit a unit assessment if: • you achieved a 'Pass' in a unit that is five or more years old, and you need it to achieve the qualification; • you are 'Referred' (i.e. don't pass); or • you want to retake a Unit to get a higher grade. There is no limit to the number of times you can re-sit unit(s) within the five-year period. Re-sit marks are not capped. If you want to try to improve your grade in a Unit, you need to tell Nebosh in writing within 20 working days of the declaration date of your successful unit.

Where can I find formative assessment and resources?

In course of your studies, you'll be required to participate in various types of formative assessments such as classwork, groupwork and syndicate sessions, workbook, OBE takehome assignments, IG1 mock examination, IG2 risk assessment. How do I confirm I have been registered for the NEBOSH IG1 Open Book Exam?

After registering for the Open Book Examination (OBE), NEBOSH will email you a Confirmation of Registration containing your learner number and essential OBE details. Verify the accuracy of your name and promptly inform us of any needed changes. If you don't receive this email on the specified date, check your spam folders or contact us immediately.
